| ROADS delivers treatment interventions (ranging from information and advice to residential treatment) across the city. There are approx. 3,500 citizens in receipt of these treatment services. 60% of these citizens are in receipt of prescribing services. Services are available to all citizens. Most referrals into treatment are from GPs and self referrals. This proposal links directly to the re-commissioning of services supported by a new commissioning model, which will developed and consulted on in December 2016. This will be informed by a full EqIA.
