# **Early Years Portage and Inclusion Service**

Bristol City Council is the data controller for the purposes of the Data Protection Act 2018 and other regulations including the General Data Protection Regulation (Regulation (EU) 2016/679), which means it determines what your data is used for and why it is collected. The purpose of this privacy notice is to tell you about what information we collect about you when you use our service, how we use that information and who we may share it with.

## Why we need to collect your data:

We will use this information for completing and reviewing educational progress over time and for planning the delivery of our service.

We will use this information to fulfil the duties placed on local authorities namely for the provision and monitoring of support and services for families with young children, and planning future services and support, in your local area, and to ensure that you are aware, and available, to attend appropriate family support services.

#### What data we need to collect:

The Early Years Portage and Inclusion Team provide support to families and early years practitioners for children from birth to 5 years, who are disabled and/or have special educational needs.

### The team offer:

- advice and guidance to all providers of early education and childcare
- a home visiting service using the Portage model. This is available to children and families via a referral process

For Early Years Practitioners and Early Years Settings, this support includes:

- providing appropriate support and interventions for individual children's needs
- developing strategies and targets for children's Individual Education Plans
- monitoring and reviewing children's rate of progress
- awareness of special educational needs processes and procedures.

### The Portage Home Visiting Service covers:

- helping families and children learn together
- providing strategies and targets to support children's development

- providing ideas for play/teaching activities to support parents/carers in stimulating their child's development
- supporting parents/carers in developing their knowledge regarding special educational needs processes and procedures.

To provide this service, we will collect the name of your child and your name as primary carer. We will also collect a date of birth, address and information relating to your child's development and wellbeing such as information about their home and family environment, summary of progress, strengths and areas of need.

# Where we have received your data from a third party:

We typically receive data from your child's setting or other professionals that work with you such as a doctor or speech therapist or we may have received information from the Bristol City Council SEN Team. Early Years Settings may share this data with us under the Special Educational Needs and Disability Code of Practice: 0 to 25 years which they will send and we receive this information in a secure email. This information is saved in a restricted access folder in the BCC IT system and the email is deleted.

We are collecting this data because we have a duty to under the *Special Educational Needs and Disability Code of Practice: 0 to 25 years* statutory guidance for organisations, which work with, and support children and young people who have special educational needs.

### What is the legal basis for our use of your personal information?

The information below shows the legal bases we are relying on to use your personal or special category (sensitive) personal information. You can see a list of the full legal bases we may rely on by looking at our full privacy notice on Bristol City Council's website.

#### **Personal information**

Our legal basis for using your personal information is to meet our legal obligations. We have a duty under the Special Educational Needs and Disability Code of Practice: 0-25 statutory guidance for organisations, which work with, and support, children and young people who have special educational needs.

# Special category (sensitive) personal information

Our additional legal basis for using your special category information is the delivery of health and social care services.

#### How long we will keep your data for:

We are required by law to hold this information until the young person is 25 years of age. After this, your child's information will be deleted.

### Who we share your data with and why:

This data will be shared with your child's early years setting (Nursery School, Nursery Class, Children's Centre, Private Day Nursery, Voluntary Play Group or Pre-School, Childminder) and with other people who work with you and the local authority SEN team where you live. For example, when an education, health and care assessment has been requested or when other professionals who are already working with you, request information to support their work with you.

#### Will my personal data be sent outside the UK?

The service uses Zoom under strict internal guidelines for video conferencing involving personal data. Data processed via Zoom is processed within the USA and safeguarded by the EU-US Privacy Shield Framework that enables the safe transfer of data under EU law. The service uses Whatsapp under strict internal guidelines for video conferencing and sending of messages involving personal data. Data processed via Whatsapp may be within the USA and other countries outside the UK and safeguarded by the EU-US Privacy Shield Framework, and standard contract clauses and adequacy decisions, as applicable that enables the safe transfer of data under EU law. No other personal information is routinely sent or held outside the UK. Should the transfer of personal information outside the UK become necessary, it will only take place if permitted by law, and then only where there are appropriate safeguards in place to protect the data.

# Your rights as a data subject:

The law gives you a number of rights to control what and how personal information is used by us, including the right to access a copy of your personal information and withdraw your consent when we rely on your permission to use your personal data.
